Membership, Rules, and Waiver of Liability Form

Note: Completion of this form is REQUIRED of all members in order to become a Voting Member of SATTTC. Furthermore, all members, guests and visitors are assumed to have accepted these provisions as evidenced by their appearance and participation in table tennis activities, regardless of whether or not they actually sign this form.

I PLEDGE TO PAY SATTTC and ALAMO FITNESS CENTER (AFC) PROMPTLY in advance of each membership period. I understand that dues are generally non-refundable and non-transferable. Options for payments of SATTTC dues:
 Option 1 (Preferred) - Pay entire calendar year (Jan 1 thru Dec 31) in one lump sum at rate of \$5.00/month.
 Option 2 Pay \$15.00 on Jan 1, Apr 1, Jul 1, and Oct 1, with first payment pro-rated at \$5.00/month if not paying entire quarter.
 Option 3 (Visitors – San Antonio residents) - Pay nothing for the first 30 days (FREE TRIAL). Then select Option 1, Option 2, or Option 4.
 Option 4 (Guests – Non-San Antonio residents) - Pay by the day only when you come to play, at the rate of \$2.00 each day.
How to pay the SATTTC: (A) Find SATTTC manila envelope at AFC front desk. (B) Print your name and all requested information CLEARLY on outside of payment envelope and insert payment into envelope. (C) Seal small envelope and place it in the manila envelope.

AFC dues (separate from and in addition to SATTTC dues) currently are \$30.00/month or \$5.00 per day drop-in fee, payable to AFC at their front desk.

Please pay promptly – both AFC dues and SATTTC dues - to avoid suspension of privileges.

I will practice courtesy, respect for others, and good sportsmanship at all times while participating in SATTTC activities. I will not purposefully strike tables, nets, or other equipment of the SATTTC or being used by the SATTTC, with paddles or other objects, and will treat all equipment of the SATTTC with care and respect. I will not throw paddles or other items, or speak profanely or make profane gestures while participating in SATTTC activities or anywhere on the property of the AFC or other place of SATTTC activities. I will abide by all future rules, regulations, policies, and procedures authorized and implemented by the SATTTC officers/Board of Directors according to the Bylaws of the SATTTC.

I will sign in on SATTTC's sign-in sheet upon arrival each day and will abide by all rules and policies of the AFC while on AFC property, including its restroom use policy: avoid using main (front) restrooms and no adult SATTTC members or guests in any restrooms being used by minor children. I will help make sure that my guests to the SATTTC/AFC complete and sign required SATTTC/AFC guest member forms upon initial arrival and that each pays the guest fee (\$2.00 per guest per day), prior to participating in additional SATTTC activities after their 30-day free trial.

Whenever all tables in one room are in use and anyone is waiting to play, I will limit warm-up (non-game) play to 5 minutes, and after I play two matches (best 3 of 5 games per match) at a table, I will relinquish use of that table to those next in line.

I will immediately and quietly leave the place where activities of the SATTTC are occurring if asked to leave by any of the officers/members of the Board of Directors of the SATTTC or by any of the staff of the AFC. If asked to leave, I will not return until granted permission to return by the SATTTC and/or the AFC and will forfeit all membership and use fees previously paid to the SATTTC or the AFC if not allowed to return. I hereby absolve the SATTTC and AFC of all claims regarding same.

I hereby release the SATTTC, its officers, board members, general members, affiliates, or guests, and the AFC, its owners, management, staff, members, and guests, from any and all claims regarding my injury, accident, or death if such injury, accident, or death occurs before, during, or after my participation in SATTTC activities, in AFC activities, or in SATTTC- or AFC-sponsored activities, at any place or at any time where such activities are occurring, including the property of the AFC. Same are hereby also absolved of any and all liability for accidental release of the above information. I hereby acknowledge reading, understanding, and receiving a copy of this Membership, Rules, Waiver of Liability Form and, by extension, the SATTTC Bylaws.
